- MIR: Maximum Information Rate. A theoretical maximum to which your bandwidth becomes available. This is the size of the complete data pipe.
- CIR: Committed Information Rate. A guarantee that, even though you share a bandwidth pool with multiple users, you are assured a dedicated rate of data transfer, no matter how congested the link becomes.
- Data Overage Blocks: Automatically added once the monthly GB allowance has been exceeded per month, until the start of the new calendar month.
- Data Bolt On: Optional purchase to avoid Data Overage Blocks.
- Only one Data Bolt On can be purchased per billed period (calendar month).
- Integra Control: Complete real-time monitoring, control and management of IP traffic and bandwidth at category and application levels.
- The minimum contract period starts from the agreed commercial / billing date. Upon completion of the minimum contract period, the service will automatically renew / re-commit on the anniversary date for the same time period, unless terminated or upgraded.
- A minimum of 80 days written notice is required to schedule termination of your service and prevent auto renewal.

- A service upgrade can be requested at any time in the billing month, 10 days written notice of change is required. For mid-month changes, there will be a prorated charge for each package. An upgrade does not extend or start a new contractual term.
- A service upgrade means moving to any plan with a higher value monthly subscription.
- Package downgrade are not allowed, this will require service deactivations. Early termination rules will apply. Customer will need to complete a new activation request to start a new minimum contract period.
- The monthly fee and allowance will be prorated in the month of activation, then charged in arrears. The month of deactivation will have the monthly fee and allowance prorated, any usage over the prorated allowance will be charged as overage.
- 45 days written notice is required for early termination. Early termination will incur a one-time charge that is equal to the US\$ value of the remaining balance of the minimum / renewal period.
- There is no rollover of unused data, this applies to monthly GB allowances / Data Overage Blocks and Data Bolt Ons.
- 1 GB = 1000 MB, 1 TB = 1000 GB
