Activation will require both the IMEI of the device and the SIM ID of the SIM card. SIMs cannot be moved between terminals.

Monthly fee will be charged prorated in the month of activation, the in bundle allowance will be applied prorated as well. Regardless of the exact deactivation date, the monthly fee is charged in full in the month of deactivation.

A service can be downgraded in line with the next billing period. A new minimum period will apply once downgraded. An early termination fee will be charged.

A service can be upgraded in line with the next billing period. A new minimum commitment period will apply once upgraded. The early termination fee does not apply even if the minimum commitment period of the tariff plan is not reached.

There is no rollover to the next month of unused in bundle data.

* The initial month of activation will not count towards the minimum commitment period if activation occurs after the 1st of the month.

It is not possible to activate several SIM cards for one device at the same time.
